ORDER ON PROCEDURE FOR CLOSE OF PROCEEDINGS

On 2 May 2008, the Trial Chamber ordered that the parties shall file their final trial briefs no later than 8 July 2008 and that the closing arguments shall be heard from 22 July until 25 July 2008.

DECISION ON OJDANIĆ MOTION FOR TEMPORARY PROVISIONAL RELEASE

On 2 May 2008, Trial Chamber III granted in part a motion by the Defence and ordered that Dragoljub Ojdanić be provisionally released on compassionate grounds from 6 May until 12 May 2008 – *See Press Release number 1247, dated 6 May 2008.*

DECISION ON THE GOTOVINA DEFENCE'S MOTION TO DISMISS COUNTS 6 AND 7 OF THE INDICTMENT
