Appeals Judgement

On 22 April 2008, the Appeals Chamber rendered its judgement partially upholding the guilt of Enver Hadžihasanović and Amir Kubura and reducing their sentences to three and a half years and two years respectively – See Press Release number 1240, dated 22 April 2008.

On 21 April 2008, the Appeals Chamber granted in part the Prosecution appeal, Judge Güney dissenting, and remanded the decision on the provisional release of the accused Petković to the Trial Chamber for a new adjudication of whether the humanitarian reasons advanced by the accused were sufficiently compelling to justify his provisional release.

FURTHER DECISION TO THE DECISION ON PROVISIONAL RELEASE OF THE ACCUSED PETKOVIĆ

On 22 April 2008, Trial Chamber III ordered, with a separate opinion of Judge Antonetti, that Milivoi Petković be provisionally relased on humanitarian grounds. The dates and subjects of provisional release were kept confidential – See Press Release number 1241, dated 22 April 2008.

SCHEDULING ORDER FOR CASE COMPLETION

On 22 April 2008, Trial Chamber I ordered that both parties shall file their final trial briefs no later than 30 May 2008. The order further stated that the Prosecution and the Defence shall present their closing arguments on 9 June and 10 June 2008 respectively and that 11 June will be reserved for the presentation of arguments in rebuttal and rejoinder, if parties so desire, and for questions asked by the Judges.
