#### **DECISION ON GVERO'S MOTION FOR PROVISIONAL RELEASE**

On 10 December 2008, pursuant to Article 29 of the Statute and Rules 54 and 65 of the Rules, Trial Chamber II granted the accused Milan Gvero's application under a number of terms and conditions set out in the decision. Mr Gvero is granted provisional release for a period not exceeding 7 days, and must return to the Detention Unit by 8 January 2009. In his application, Mr Gvero had requested provisional release for the period 19 December 2008 to 12 January 2009.

#### **DECISION ON MILETIĆ'S MOTION FOR PROVISIONAL RELEASE**

On 10 December 2008, pursuant to Article 29 of the Statute and Rules 54 and 65 of the Rules, Trial Chamber II granted the accused Radivoje Miletić's application for provisional release under a number of terms and conditions set out in the decision. Mr Miletić is granted provisional release for a period not exceeding 7 days, and must return to the Detention Unit by 8 January 2009.

#### **DECISION ON LAZAREVIĆ MOTION FOR PROVISIONAL RELEASE**

On 10 December 2008, pursuant to Article 29 of the Statute and Rules 54 and 65 of the Rules, Trial Chamber II denies the accused Lazarević's application for provisional release.
