#### **SCHEDULING ORDER**

On 6 February 2009, the Trial Chamber ordered that, considering that according to current projections, the Prosecution will close its case no later than the week of 2 March 2009, oral submissions by the parties pursuant to Rule 98*bis* of the Rules shall commence on the 10<sup>th</sup> working day after the close of the Prosecution case. In the event there is a need for a Defence case, the Pre-Defence Conference shall be held on the 18<sup>th</sup> working day after the conclusion of the Rule 98*bis* submissions whereas the Defence case shall commence on the 19<sup>th</sup> working day after the conclusion of the Rule 98*bis* submissions.

### **MILUTINOVIĆ et al. Case**

*Trial Chamber III – Judges Bonomy (Presiding), Chowhan, Kamenova and Nosworthy (Reserve Judge)*

#### **DECISION ON LAZAREVIĆ MOTION FOR TEMPORARY PROVISIONAL RELEASE**

On 9 February 2009, the Trial Chamber granted a motion by Vladimir Lazarević and ordered that he be provisionally released on compassionate grounds from 11 February until 23 February 2009.

#### **DECISION ON ŠAINOVIĆ MOTION FOR TEMPORARY PROVISIONAL RELEASE**

On 9 February 2009, the Trial Chamber denied a motion for temporary provisional release on the compassionate grounds for Nikola Šainović.

### **HARAQIJA&MORINA Case (“Contempt”)**

#### **DECISION ON MOTION OF BAJRUSH MORINA FOR PROVISIONAL RELEASE**

On 9 February 2009, the Appeals Chamber granted a motion by Bajrush Morina and ordered that he be provisionally released pending the appeals judgement - *See Press Release number 1302, dated 9 February 2009.*

### **Vladimir ŠANTIĆ (“Kupreškić et al.”) Case**

*Judge Robinson – President of the ICTY*

#### **DECISION OF THE PRESIDENT ON THE APPLICATION FOR PARDON OR COMMUTATION OF SENTENCE OF VLADIMIR ŠANTIĆ**

On 9 February 2009, Judge Robinson granted a request for early release of Vladimir Šantić.

### **LUKIĆ&LUKIĆ Case**

*Trial Chamber III – Judges Robinson (Presiding), Van den Wyngaert and David*

#### **SCHEDULING ORDER**

On 10 February 2009, Trial Chamber III, considering that it has become necessary, in the interests of the proceedings, to temporarily suspend the trial for two weeks, scheduled the trial to resume on 25 February 2009.

### **Vojislav ŠEŠELJ Case**

#### **DÉCISION RELATIVE À LA REQUÊTE DE L’ACCUSATION AUX FINS D’AJOURNEMENT AVEC EN ANNEXE L’OPINION DISSIDENTE DU JUGE ANTONETTI**

On 11 February 2009, Trial Chamber III issued a majority decision granting a motion by the Prosecution for an adjournment of the proceedings due to alleged threat to a number of Prosecution witnesses. Judge Antonetti appended a dissenting opinion.

### **Vojislav ŠEŠELJ Case (“Contempt”)**

#### **DECISION**

On 11 February 2009, Acting Registrar Hocking decided to appoint Mr Bruce MacFarlane, Q.C. as *amicus curiae* to prosecute the alleged knowing and wilful

disclosure of information in knowing violation of an order of a Chamber by Vojislav Šešelj.

## **KARADŽIĆ Case**

*Vice-President of the ICTY Judge Kwon*

### **DECISION ON RADOVAN KARADŽIĆ'S REQUEST FOR REVERSAL OF DENIAL OF CONTACT WITH JOURNALIST**

On 12 February 2009, Judge Kwon granted in part an application by Radovan Karadžić and ordered that he be permitted to contact Ms Zvezdana Vukojević of the Dutch "Revu" magazine via written correspondence, telephone calls or whatever other means the Registrar deems appropriate. All communication between the accused and Ms Vukojević will be monitored by Registry personnel. Ms Vukojević shall be put on notice that any failure to comply with her obligations as a member of the media pursuant to the rules and requirements of the Tribunal will expose her to investigation and possible prosecution for contempt.
