On 24 April 2009, the Trial Chamber granted the Prosecution's request to recall witness Marko Rajčić and scheduled the testimony for 25 May 2009.

DECISION ON PROSECUTION MOTION FOR REVOCATION OF JOVICA STANIŠIĆ'S PROVISIONAL RELEASE AND RE-ASSESSMENT OF HIS HEALTH AND REVOCATION OF FRANKO SIMATOVIĆ'S PROVISIONAL RELEASE

On 24 April 2009, the Trial Chamber decided that the trial in this case shall recommence and ordered Jovica Stanišić and Franko Simatović to return to the UN Detention Unit in the Hague by 4 May 2009.

SCHEDULING ORDER FOR RECOMMENCEMENT OF TRIAL

On 24 April 2009, the Trial Chamber ordered that:

- the Pre-Trial Conference shall be held on 18 May 2009;
- the opening statement of the Prosecution will be delivered on 25 May 2009;
- presentation of evidence by the Prosecution shall recommence on 2 and 3 June 2009;
- witnesses heard or exhibits admitted at the initial commencement of trial proceedings shall not be considered as evidence without presentation anew following recommencement of trial.

DECISION ON MOTION AND SUPPLEMENTARY MOTION FOR LEAVE TO AMEND THE INDICTMENT
