*Trial Chamber I – Judges Orić (Presiding), Picard and Gwaunza*

### **DECISION ON START OF TRIAL AND MODALITIES FOR TRIAL**

On 29 May 2009, Trial Chamber I concluded that the trial in this case shall commence pursuant to a number of modalities, such as:

- The Chamber will only hold hearings two days a week; the daily hearings will be divided into sessions of 1 hour and 15 minutes, with breaks lasting 30 minutes;
- Jovica Stanišić will be physically present in court but as with all other accused he may waive his right to be present;
- The Chamber will allow the accused Stanišić, if he opts to, not to be present in court but instead follow the proceedings via a video-conference link from the UN Detention

Unit. A telephone line will allow him to communicate with his counsel in the courtroom and he may be accompanied by a member of his Defence team in the Detention Unit.

## SCHEDULING ORDER

On 5 June 2009, Trial Chamber I ordered that the opening statement of the Prosecution will be delivered on 9 June and may continue until 10 June 2009. The presentation of evidence by the Prosecution shall commence on 29 June and may continue on 30 June 2009.
