ORDER RECALLING LAHI BRAHIMAJ FROM PROVISIONAL RELEASE

On 5 October 2009, the Appeals Chamber ordered Lahi Brahimaj to return to the UN Detention Unit in The Hague for the duration of the appeal hearing scheduled for 28 October 2009. The provisional release shall resume after the hearing.

DECISION ON THE APPLICATION OF RULE 73bis

On 8 October 2009, the Trial Chamber decided as follows:

- The Prosecution may not present evidence in respect to the crimes sites and incidents proposed to be removed in the Prosecution's submission filed on 31 August 2009;
- The Prosecution shall lead all of its evidence within a total of 300 hours;
- The Prosecution shall file a marked-up version of the indictment by 19 October 2009;
- The Prosecution shall file a revised Rule 65ter exhibit list by 19 October 2009.
