DECISION ON MOTION TO STAY PAYMENT OF FINE

On 9 October 2009, the Appeals Chamber decided that the payment of fine, if any, shall not be due before the rendering of the appeals judgement.

On 9 October 2009, the Defence filed its appeal brief against the judgement.

DECISION ON KARADŽIĆ'S APPEAL OF TRIAL CHAMBER'S DECISION ON ALLEGED HOLBROOKE AGREEMENT(*)

On 12 October 2009, the Appeals Chamber dismissed the appeal by Radovan Karadžić against the decision denying his motion to dismiss the indictment because of the alleged "Holbrooke Agreement" and concluded, *inter alia*, that "even if the alleged agreement were proved, it would not limit the jurisdiction of the Tribunal, it would not otherwise be binding on the Tribunal and it would not trigger the doctrine of abuse of process."

DECISION ON RADOVAN KARADŽIĆ'S APPEAL OF THE DECISION ON COMMENCEMENT OF TRIAL(**)

On 13 October 2009, the Appeals Chamber ordered the Trial Chamber to delay the commencement of the trial until one week after the Prosecution's filing of the marked-up indictment.

SCHEDULING ORDER FOR THE COMMENCEMENT OF TRIAL^(*)**

On 14 October 2009, the Trial Chamber ordered that the trial shall commence on Monday, 26 October 2009 at 09:00 a.m. in Courtroom I.

ORDER SEVERING RATKO MLADIĆ^(*)**

On 15 October 2009, the Trial Chamber ordered that the accused Ratko Mladić be severed from case number IT-95-5/18 and the Registry shall assign a new case number to any further submissions or proceedings that involve Mladić.

Trial Chamber I – Judges Orić (Presiding), Picard and Gwaunza

DECISION ON MOTION FOR ADJOURNEMENT OF PROCEEDINGS BY THE SIMATOVIĆ DEFENCE

On 15 October 2009, the Trial Chamber granted the motion by the Simatović Defence for the adjournment of proceedings (due to “*the formation of a new Defence team*”) and decided that:

- the hearing in the present case shall recommence during the week of 30 November 2009;
- the regular winter judicial recess of the Tribunal scheduled between 21 December 2009 and 8 January 2010 shall be prolonged for the purposes of this case and hearings in these proceedings shall recommence during the week of 18 January 2010;
- during the period between the week of 30 November and the week of 14 December 2009, the Chamber shall maintain a two day per week sitting schedule and shall revisit this schedule after 18 January 2010.

DECISION ON SIMATOVIĆ DEFENCE MOTION REQUESTING PROVISIONAL RELEASE

On 15 October 2009, the Chamber granted the Defence motion and ordered that Franko Simatović be provisionally released from 19 October until 25 November 2009.
