# PROCEDURAL DEVELOPMENTS:

#### I. **OVERVIEW OF COURT PROCEEDINGS:**

# MILOŠEVIĆ Case ("Croatia and Bosnia and Herzegovina")

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

37<sup>th</sup> week of the Prosecution case.

On 28 July 2003, the trial was adjourned due to the ill health of the Accused and on 29 July hearings were cancelled for the remainder of the week. On 30 July 2003, an administrative hearing took place in the absence of the Accused.

The trial is scheduled to continue on 25 August 2003.

# **BRĐANIN** Case ("Krajina")

Trial Chamber II Section A – Judges Agius (Presiding), Janů and Taya

45<sup>th</sup> week of the Prosecution case.

From 28 July until 1 August 2003, the following witness was examined by the Prosecution and subsequently cross-examined by the Defence:

- Witness Jovo Radojko
- Witness Milorad Dodik

The trial is scheduled to continue on 27 August 2003.

# **ORIĆ Case**

Pre-Trial Judge Kwon

On 29 July 2003, the parties appeared before the Pre-Trial Judge for a Status Conference pursuant to Rule 65 bis (A) of the Rules of Procedure and Evidence.

# KRSTIĆ Case ("Srebrenica")

Presiding Judge Meron

On 30 July 2003, the parties appeared before President Meron for a Status Conference pursuant to Rule 65 bis (B) of the Rules of Procedure and Evidence.

STAKIĆ Case ("Prijedor")

Trial Chamber II – Judges Schomburg (Presiding), Vassylenko and Argibay

On 31 July 2003, the Trial Chamber convened for the pronouncement of the Judgement. Milomir Stakić was found guilty of four counts of crimes against humanity and one count of violations of the laws or customs of war. He was sentenced to life imprisonment (see *Press Release* No.774).
