PROCEDURAL DEVELOPMENTS:

I. OVERVIEW OF COURT PROCEEDINGS:

MILOŠEVIĆ Case (“Croatia and Bosnia and Herzegovina”)

Trial Chamber III – Judges May (Presiding), Robinson and Kwon

43rd week of the Prosecution case.

From 14 until 16 October 2003, the following witnesses were examined by the Prosecution and subsequently cross-examined by the Accused and one of the *amici curiae*:

- Witness Milan Milanović (continuation of cross-examination)
- Protected Witness B-1115

- Protected Witness B-1453 (not cross-examined by the *amici curiae*)

KVOČKA *et al.* Case (“Omarska, Keraterm and Trnopolje Camps”)

Pre-Appeal Judge Weinberg de Roca

On 13 October 2003, the parties appeared before the Pre-Appeal Judge for a Status Conference pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence.

BRĐANIN Case (“Krajina”)

Trial Chamber II Section A – Judges Agius (Presiding), Janů and Taya

On 15 and 16 October 2003, the Defence cross-examined Prosecution expert witness Patrick Treanor. On 17 October 2003, the hearing took place mainly in closed session.

KORDIĆ and ČERKEZ Case (“Lašva Valley”)

Pre-Appeal Judge Schomburg

On 15 October 2003, the parties appeared before the Pre-Appeal Judge for a Status Conference pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence.

SIMIĆ *et al.* Case (“Bosanski Šamac”)

Trial Chamber II Section B – Judges Mumba (Presiding), Williams and Lindholm

On 17 October 2003, the parties appeared before the Trial Chamber for the pronouncement of the Judgement in the proceedings against Blagoje Simić, Miroslav Tadić and Simo Zarić. The Trial Chamber sentenced Blagoje Simić to 17 years, Miroslav Tadić to 8 years and Simo Zarić to 6 years' imprisonment (see *Press Release No.792*). Judge Lindholm appended a separate and partly dissenting opinion to the Judgement.

2. That Professor Dr. Ulrich Sieber is to file his expert report relating to sentencing practices no later than Thursday, 23 October 2003 at 12 p.m.

The sentencing hearing is scheduled to take place from 3 to 7 November 2003 (see *Weekly Update* No. 281).

On 10 October 2003, the Trial Chamber ordered *inter alia* Miroslav Deronjić to appear as a witness before the Trial Chamber at the Sentencing Hearing of Momir Nikolić on Tuesday, 28 October 2003.
