Appeals Chamber – Judges Pocar (Presiding), Shahabuddeen, Vaz, Meron and Schomburg

Appeals judgement

On 27 September 2007, the Appeals Chamber dismissed the appeals by the parties and affirmed acquittals of the accused Limaj and Musliu and the sentence of 13 years' imprisonment for Haradin Bala – See Press Release number 1184, dated 27 September 2007.

Judgement

On 27 September 2007, the Trial Chamber rendered its judgement: Mile Mrkšić and Veselin Šljivančanin were sentenced to 20 years' and five years' imprisonment, respectively, while Miroslav Radić was acquitted of all charges – See Press Release number 1185, dated 27 September 2007.
