**THE APPEALS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia Since 1991 (“International Tribunal”),

**NOTING** that Trial Chamber I rendered its Judgement in this case orally on 17 January 2005 and in writing on 24 January 2005 (“Judgement”);

**NOTING** the “Prosecution’s Brief on Appeal”, filed on 9 May 2005, the “Response Brief of Dragan Jokić”, filed on 20 June 2005, the “Defence of Accused Mr. Vidoje Blagojević Response Brief on Prosecution’s Brief on Appeal Filed on 9 May 2005”, filed on 20 June 2005, and the “Prosecution’s Brief in Reply”, filed on 5 July 2005;

**NOTING** the “Defence of Accused Mr. Vidoje Blagojević Brief on Appeal”, filed on 20 October 2005, the “Prosecution Response to Appeal Brief of Vidoje Blagojević”, filed on 9 or 16 December 2005, and the “Defence of Vidoje Blagojević Response to Prosecution Response to Appeal Brief of Vidoje Blagojević (Confidential)”, filed on 27 December 2005;<sup>1</sup>

**NOTING** the “Appeal Brief of Dragan Jokić”, filed on 4 October 2005, the “Amended Appeal Brief of Dragan Jokić”, filed on 1 December 2005, the “Third Amended Appellate Brief of Dragan Jokić”, filed on 6 July 2006, the “Prosecution Amended Consolidated Response Brief (Confidential and Partly *Ex Parte*)”,<sup>2</sup> filed on 20 July 2006, and the “Reply of Dragan Jokić to Prosecution Amended Consolidated Response brief (20 July 2006) (Confidential)”, filed on 2 August 2006;

**NOTING** that Rule 114 of the Rules of Procedure and Evidence of the International Tribunal provides, *inter alia*, that “[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing”;

**CONSIDERING** that the filing of the briefs in the Appeals is complete;

**HEREBY ORDERS** that the hearing of the Appeals shall take place in Courtroom 2 on the morning of Tuesday 5 December 2006 and during the morning of Wednesday 6 December 2006; and
