PROSECUTION REQUEST FOR LEAVE TO FILE  
CONSOLIDATED RESPONSE TO PENDING MOTIONS BY  
THE ACCUSED BLAGOJEVIĆ AND ACCUSED JOKIĆ, AND  
TO ANTICIPATED MOTION BY ACCUSED OBRENOVIĆ,  
FOR PRODUCTION OF EVIDENCE**

**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia ("International Tribunal")

**BEING SEIZED** of the "Prosecution Request for Leave to File Consolidated Response to Pending Motions by the Accused Blagojević and Accused Jokić, and to Anticipated Motion by Accused Obrenović, for Production of Evidence" ("Request") filed by the Office of the Prosecutor ("Prosecution") on 19 April 2002

**NOTING** that the accused Vidoje Blagojević and the accused Dragan Jokić have filed motions for production of evidence on 8 April 2002 and 15 April 2002, respectively, pursuant to Rule 66(B) of the Rules of Procedure and Evidence of the International Tribunal ("Rules")

**NOTING** that the Prosecution's response to the pending motion for production of witness statements by the accused Blagojević was due on Monday, 22 April 2002, and that the Prosecution's Response to the pending motion for disclosure of evidence by the accused Jokić is due on Monday, 29 April, 2002

**NOTING** that the Prosecution has communicated with counsel for Dragan Obrenović, Mr. Eugene Wilson, and has learned that the defence intends to file a motion regarding, in essence, the same issues in the motion of the accused; and that counsel for indicated that their motion would be filed during the week of 22 April 2002;


**CONSIDERING** that the anticipated Obrenović motion is likely to contain arguments that would be of benefit to the Trial Chamber and to the Prosecution in consideration of the issues to be decided;

**GRANTS** the Prosecution leave to file a consolidated response to the motions of Blagojević, Obrenović, and Jokić; and,

**NOTING** the Prosecution's submission that it has already had an opportunity to consider the pending issues, and that the Prosecution will be in a position to file its consolidated response seven (7) days following the receipt of the Obrenović motion thereby expediting the Trial Chamber's consideration of the issue;

**ORDERS** that the Prosecution's consolidated response shall be due seven (7) days following receipt of the anticipated Obrenović motion.
