**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("International Tribunal");

**BEING SEISED** of a Motion for Leave to Exceed Page Limits<sup>1</sup> filed by the accused Momir Nikolić, in which he seeks leave to exceed the page limits set out in the Practice Direction<sup>2</sup> in connection with his Preliminary Motion<sup>3</sup> filed on 27 June 2002,

**NOTING** the Practice Direction on the Length of Briefs and Motions<sup>4</sup> dated 5 March 2002 ("Practice Direction") which provides that a motion before a Chamber "will not exceed 10 pages or 3,000 words, whichever is greater",

**NOTING** that, pursuant to the Practice Direction, "a party must seek authorization in advance from the Chamber to exceed the page limits in this Practice Direction and must provide an explanation of the exceptional circumstances that necessitate the oversized filing",


**NOTING** that the Preliminary Motion is 20 pages in length,

**CONSIDERING** that the complexity of the issues raised in the Preliminary Motion constitutes an exceptional circumstance that necessitates the oversized filing,

**HEREBY GRANTS** leave as requested and accepts the Preliminary Motion as filed.
