**I, Carmel Agius**, Presiding Judge of Trial Chamber II of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the Order dated 23 November 2006, which ordered that Trial Chamber II in the case of *Prosecutor v. Ljube Bošković and Johan Tarčulovski* shall be composed of Judge Carmel Agius (Presiding), Judge Kevin Parker and Judge Kimberly Prost for the purposes of pre-trial proceedings, and designating Judge Kevin Parker as Pre-Trial Judge;
