DECISION ON ASTRIT HARAQIJA'S REQUEST TO VARY CONDITION OF PROVISIONAL RELEASE

Khan for Astrit Haraqija Mr. Jens Dieckmann for Bajrush Morina **TRIAL CHAMBER I** ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of Former Yugoslavia since 1991 ("Tribunal");

BEING SEISED of the "Astrit Haraqija's Request to Vary Condition of Provisional Release with Confidential Annex", filed publicly on 6 October 2008 ("Motion")¹ in which the Defence for Astrit Haraqija ("Accused") seeks the variation of a condition of the provisional release in order to allow the Accused to visit his parents in Gjakova, Kosovo, once per week;

NOTING that the Indictment in the present case was confirmed on 12 February 2008² and on 28 April 2008, the Accused was transferred to the seat of the Tribunal;

NOTING that on 13 May 2008, the Accused was granted provisional release pending the start of the trial ("Pre-trial provisional release");³

NOTING that on 3 September 2008, the Accused was recalled from provisional release⁴ and on 15 September 2008 was granted further provisional release pending the finalisation of the judgement;⁵

NOTING that one of the conditions of the present provisional release is that the Accused shall remain within the confines of the municipality of his residence;⁶

NOTING that in its response filed on 6 October 2008, the Prosecution did not oppose the Motion;⁷

CONSIDERING that the Accused up to now has abided to all conditions of both the Pre-trial and present provisional release;

CONSIDERING that UNMIK did not submit any objections as to the modifications of the terms of the provisional release sought by the Defence;⁸

On 1 October 2008, the Defence confidentially filed "Astrit Haraqija's Request to Vary Condition of Provisional Release" that was subsequently replaced by the public version with confidential annex. The Trial Chamber notes that both submissions are materially identical and that the only difference is that the public version contains the references to the place of residence of Astrit Haraqija's family in the confidential annex.

FINDING that allowing the Accused to visit his parents at their family home in Gjakovo once per week will not create a risk of flight;

GRANTS the Motion and MODIFIES the conditions set in its Decision on Provisional Release as follows:

The Accused is allowed to leave his place of residence in consultation with UNMIK every Saturday between 10.00 and 18.00 in order to visit his parents in Gjakovo.
