**TRIAL CHAMBER I** (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of Former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the indictment against Astrit Haraqija and Bajrush Morina (“Accused”), filed on 8 January 2008 and confirmed on 12 February 2008;

**NOTING** that the President of the Tribunal has assigned this case to Trial Chamber I for trial<sup>1</sup> and that therefore, the Bench hearing the case has been composed;<sup>2</sup>

**NOTING** the information provided by the Registry that both Accused will be transferred to the United Nations Detention Unit later today;

**NOTING** that Rule 62 of the Tribunal’s Rules of Procedure and Evidence provides that an accused, upon transfer to the seat of the Tribunal, shall be brought before a Trial Chamber or a judge thereof “without delay, and shall be formally charged”;

**PURSUANT TO** Rule 62 of the Rules of Procedure and Evidence of the Tribunal;

**HEREBY ORDER** that the initial appearance of the Accused shall be held before me on 29 April 2008 at 14:15 hours in Courtroom I.
