## DECISION ON AMICUS CURIAE PROSECUTOR'S FURTHER REQUEST FOR ASSISTANCE

## Amicus Curiae Prosecutor

## The Government of the Republic of Serbia

Per: The Embassy of the Republic of Serbia to the Kingdom of the Netherlands

TRIAL CHAMBER I of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Chamber" and "Tribunal", respectively);

NOTING that on 28 August 2017, the Chamber requested the Republic of Serbia ("Serbia") to provide documents requested by the amicus curiae Prosecutor ("Decision"); ${ }^{1}$

NOTING that on 18 September 2017, the Registry informed the Chamber that it had received documents from Serbia, which it forwarded to the amicus curiae Prosecutor pursuant to the Decision; ${ }^{2}$

BEING SEISED of the amicus curiae Prosecutor's further request, filed on 3 October 2017 ("Further Request"), submitting that the documentation provided is incomplete and seeking the Chamber's assistance in order to obtain: (i) the transcript of the review proceedings in the War Crimes Chamber of the High Court on 17 May 2016; (ii) the audio-recordings of both hearings of 17 May 2016 (Preliminary Proceedings and Review Proceedings); and (iii) a copy of the summons relating to each accused by which their attendance was obtained at the court in Belgrade on 17 May 2016 (collectively "Further Documents"); ${ }^{3}$

NOTING that on 3 August 2017, in response to an earlier invitation by the Chamber, Serbia stated, inter alia, that there were no obstacles to providing the sought material; ${ }^{4}$

CONSIDERING Serbia's willingness to assist the Tribunal in this respect;

CONSIDERING that the direct communications between Serbia and the amicus curiae Prosecutor in the past have not led to an expeditious resolution of the matter;

PURSUANT TO Article 29 of the Tribunal's Statute;
GRANTS the Further Request;

REQUESTS Serbia to provide the Further Documents, within two weeks of the date of this decision, to the Registrar of the Tribunal; and

[^0]REQUESTS the Registrar to provide the amicus curiae Prosecutor with the Further Documents upon receipt.
