I, **CARMEL AGIUS**, Judge of the Appeals Chamber of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Appeals Chamber” and “Tribunal”, respectively), and Pre-Appeal Judge in this case,¹

NOTING the judgement rendered by Trial Chamber II on 23 February 2011;²

NOTING the “Prosecution Notice of Appeal” and “Vlastimir Đorđević’s Notice of Appeal”, both filed on 24 May 2011;

NOTING that Vlastimir Đorđević is currently in custody at the United Nations Detention Unit in The Hague;

CONSIDERING that, pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence of the Tribunal (“Rules”), a status conference shall be convened within one hundred and twenty days after the last status conference, to allow any person in custody pending appeal the opportunity to raise issues in relation thereto, including the mental and physical condition of that person;


NOTING that the last status conference was held on 11 May 2012;
