**NOTING** Security Council Resolution 1800 (2008), which allows the Secretary-General to appoint additional *ad litem* Judges to the maximum of twelve *ad litem* Judges authorized under the Statute of the International Tribunal (“Statute”);

**NOTING** the “Order Reassigning a Case to a Trial Chamber” issued on 22 November 2006, which reassigned this case to Trial Chamber I;

**CONSIDERING** Articles 12, 13, 13*ter* (2) and 14(5) of the Statute;

**HEREBY ASSIGN** Judge Uldis Ķiniš and Judge Elizabeth Gwaunza to Trial Chamber I for the trial of Case No. IT-06-90, *The Prosecutor v. Ante Gotovina et al.*, effective, today, 3 March 2008.
