

1. Subsequent to the filing of its “Decision on Conflict of Interest of Attorney Miroslav Šeparović” of 27 February 2007 (“Decision on Conflict of Interest”) and its “Decision on Finding of Misconduct of Attorney Miroslav Šeparović” of 6 March 2007 (“Decision on Finding of Misconduct”) (collectively “Decisions”), the Trial Chamber noticed that the Decisions contained typographical errors.
2. Footnote 10 of the Decision on Finding of Misconduct and Footnote 32 of the Decision on Conflict of Interest should have cited the *Prosecutor v. Enver Hadžihasanović et al* case as Case No.: IT-01-47-PT, “Decision on Prosecution’s Motion for Review of the Decision of the Registrar to Assign Mr. Rodney Dixon as Co-Counsel to the Accused Kubura”, 26 March 2002.
3. Furthermore, Footnote 33 of the Decision on Conflict of Interest should have referred to the “*Prlić* Decision, para. 16” and should have been cited in the preceding paragraph.
4. The Trial Chamber orders such amendments to the Decisions.
