**TRIAL CHAMBER I** (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**RECALLING** the “Decision on Ante Gotovina’s Preliminary Motions alleging Defects in the Form of the Joinder Indictment” of 19 March 2007, wherein the Trial Chamber ordered the Prosecution to submit clarifications in relation to the defects of the Joinder Indictment established in paragraphs 14, 16, 19, 38, 45 and 48 of the Decision, by 26 March 2007 (“Order”);


**BEING SEIZED** of the Prosecution’s “Motion for Extension of Time” of 23 March 2007 (“Request”), wherein the Prosecution requested a two-day extension of time to comply with the Order because of the absence of key personnel within its Office;

**CONSIDERING** that the Prosecution’s Request is reasonable and it is in the interests of justice to grant it;

**PURSUANT TO** Rule 54 of the Rules of Procedure and Evidence,

**HEREBY GRANTS** the Request.
