I, CARMEL AGIUS, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

NOTING the “Consolidated Decision on the Continuation of the Proceedings”, issued on 26 October 2015 by Trial Chamber II of the Tribunal (“Trial Chamber”);¹

NOTING the “Decision on Prosecution Request for Certification to Appeal Consolidated Decision on the Continuation of Proceedings”, issued on 24 November 2015, in which the Trial Chamber granted the request by the Office of the Prosecutor of the Tribunal (“Prosecution”) for certification to appeal the Impugned Decision;²

NOTING the “Prosecution’s Urgent Interlocutory Appeal from Consolidated Decision on the Continuation of Proceedings”, filed by the Prosecution on 1 December 2015;

CONSIDERING Articles 12(3) and 14(3) of the Statute of the Tribunal and Rules 73(B) and (C) of the Rules of Procedure and Evidence of the Tribunal (“Rules”);

NOTING that Rule 19(A) of the Rules authorises the President to coordinate the work of the Chambers;

CONSIDERING the composition of the Appeals Chamber of the Tribunal set out in document IT/263/Rev. 9, issued on 17 November 2015;

CONSIDERING the appeal management and case distribution needs of the Tribunal;


