**I, THEODOR MERON**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the judgement of acquittal on Count 1 (Genocide) of the indictment in the case of *Prosecutor v. Radovan Karadžić*, Case No. IT-95-5/18-T, rendered orally by Trial Chamber III on 28 June 2012 pursuant to Rule 98bis of the Rules of Procedure and Evidence of the Tribunal (“Rules”);<sup>1</sup>

**NOTING** the “Prosecution Notice of Appeal of Judgement of Acquittal Under Rule 98bis”, filed by the Office of the Prosecutor on 11 July 2012;

**CONSIDERING** Articles 12(3) and 14(3) of the Statute of the Tribunal and Rule 108 of the Rules;

**NOTING** that Rule 19(A) of the Rules authorises the President to coordinate the work of the Chambers;

**CONSIDERING** the composition of the Appeals Chamber of the Tribunal as set out in document IT/263/Rev. 3, filed on 5 July 2012;

**CONSIDERING** the appeal management and case distribution needs of the Tribunal;


