I, FAUSTO POCAR, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“International Tribunal”),

NOTING the “Order Assigning Judges to a Case before the Appeals Chamber and Appointing a Pre-Appeal Judge” filed 26 October 2006;

NOTING the “Order Re-Assigning a Pre-Appeal Judge in a Case Before the Appeals Chamber” issued on 2 November 2006, which designated Judge Wolfgang Schomburg as Pre-Appeal Judge in this case;

CONSIDERING that this case is in its pre-appeal phase and that, therefore, no hearing in this case has been held;

CONSIDERING the composition of the Appeals Chamber of the International Tribunal as set out in document IT/245 issued on 12 May 2006;

CONSIDERING the appeal management needs of the International Tribunal;

CONSIDERING FURTHER that pursuant to Article 14(2) of the Statute and Rules 65^{ter} and 107 of the Rules of Procedure and Evidence of the International Tribunal, I shall designate a Pre-Appeal Judge responsible for pre-appeal proceedings in a case;

HEREBY ASSIGN, with immediate effect, Judge Mehmet Güney to replace Judge Wolfgang Schomburg;

HEREBY ASSIGN, with immediate effect, Judge Theodor Meron in replacement of Judge Wolfgang Schomburg as Pre-Appeal Judge in this case;

AND ORDER that the Bench in *Prosecutor v. Momčilo Krajišnik*, Case No. IT-00-39-A, shall be composed as follows:
