THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

BEING SEIZED OF the appeals lodged by the Office of the Prosecutor (“Prosecution”) and by the Defence against the Judgement rendered in this case by Trial Chamber I on 12 June 2007;¹

CONSIDERING that the briefing on appeal in this case is complete;

PURSUANT to Rule 114 of the Rules of Procedure and Evidence of the Tribunal, which provides that “[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing and the Registrar shall notify the parties”;

HEREBY ORDERS that the hearing in the present appeal shall be held on Wednesday, 25 June 2008, and Thursday, 26 June 2008, in Courtroom I, and **INFORMS** the parties that the timetable for the hearing shall be as follows:
