# ORDER REGARDING THE ALTERATION OF THE STATUS OF EXHIBITS CONSISTING OF TRANSCRIPTS FROM OTHER CASES

I, MEHMET GÜNEY, Judge of the Appeals Chamber of the International Criminal Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "Tribunal", respectively) and Pre-Appeal Judge in this case;<sup>1</sup>

**NOTING** that unofficial and unrevised versions of transcripts from other cases have been publicly admitted in the trial phase of the instant case as exhibits P37, P38, P127, P173, P175 and P179 ("Exhibits") and that the Registry has advised the Appeals Chamber that the Exhibits contain confidential passages that have been redacted from the public record in their respective cases;

**CONSIDERING** that exhibits containing passages from transcripts designated as confidential in another case shall not be publicly accessible and that accordingly the Registry has not made the Exhibits available to the public through the ICTY Court Records;

**CONSIDERING** that by virtue of Rules 78 and 107 of the Rules of Procedure and Evidence ("Rules"), all proceedings before the Appeals Chamber shall be public unless there are exceptional reasons for keeping them confidential and that the identified Exhibits in the instant case had been originally submitted by the parties as public exhibits;<sup>2</sup>

**CONSIDERING THEREFORE** that it is necessary to have a public redacted version of the Exhibits in the instant case;

**NOTING** the "Order Regarding the Status of Exhibits Consisting of Transcripts from Other Cases" filed on 28 June 2010 ("28 June 2010 Order"), in which the Appeals Chamber ordered

the parties to replace, without undue delay and in consultation with the Registry, the unofficial and unrevised versions of transcripts which were admitted as public or confidential exhibits throughout the trial proceedings in the *Lukić* and *Lukić* case with the official and revised versions of those transcripts;<sup>3</sup>

**CONSIDERING** that the Exhibits as submitted by the parties should not be replaced by "official and revised versions" of the transcripts that make up the Exhibits and that the 28 June 2010 Order should therefore be set aside;

HEREBY ORDER that the Registry, as soon as practicable, designate as confidential the Exhibits;

**ORDER** the Prosecution, in close cooperation with the Registry, to provide public redacted versions of the Exhibits as admitted during trial, to upload them in the eCourt system by 9 December 2010, and to notify the Registry and the Appeals Chamber when they are uploaded; and

**INSTRUCT** the Registry to assign, as soon as practicable, exhibit numbers to the public redacted versions of the Exhibits in the instant case, and to file a notification to the Appeals Chamber, which would be copied to the parties, in which those exhibit numbers are indicated.
