**THE APPEALS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Appeals Chamber” and “Tribunal”, respectively);

**BEING SEISED** of the appeals lodged by the Office of the Prosecutor (“Prosecution”)<sup>1</sup> and by Milan Lukić<sup>2</sup> and Sredoje Lukić<sup>3</sup> against the Judgement rendered in this case by Trial Chamber III on 20 July 2009;<sup>4</sup>

**CONSIDERING** that the briefing on appeal in this case is complete;

**RECALLING** that during the last status conference on 10 March 2011, the Pre-Appeal Judge informed the parties that “[t]he Appeals Chamber will set officially the hearing date in due time”;<sup>5</sup>

**NOTING** that Rule 114 of the Rules of Procedure and Evidence provides that “[a]fter the expiry of the time-limits for filing the briefs provided for in Rules 111, 112 and 113, the Appeals Chamber shall set the date for the hearing and the Registrar shall notify the parties”;

**HEREBY ORDERS** that the appeal hearing shall take place on Wednesday 14 September 2011 and Thursday 15 September 2011, in a courtroom to be determined and **INFORMS** the parties that the timetable for the appeal hearing shall be as follows, subject to adjustments as appropriate:

**INFORMS** the parties that other modalities of the appeal hearing, including questions the parties will be invited to address, will be specified in due course by further order.
