

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of a “Withdrawal of Request for Binding Order to the Government of the United Kingdom,” filed by the Ojdanić Defence on 1 February 2007 (“Motion”), withdrawing its motion for an order to the Government of the United Kingdom pursuant to Rule 54 *bis* of the Rules of Procedure and Evidence of the Tribunal (“Rules”).¹

1. In the Motion, the Ojdanić Defence informs the Chamber that the Government of the United Kingdom has produced to it all requested information pertaining to the anticipated testimony of Colonel John Crosland and that therefore the Ojdanić Defence would like to withdraw its pending Motion for an order against the United Kingdom.
2. Pursuant to Rules 54 and 54 *bis* of the Rules, the Chamber hereby CONFIRMS the Ojdanić Defence’s withdrawal of the Motion.
