THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of the “Prosecution Notice Regarding Status of English Translation For Exhibit P1527”, filed 27 April 2007, and hereby issues this order.

1. On 18 April 2007, the Prosecution filed its “Request for Leave to Replace English Version of Exhibit P01527 in e-Court,” in order to substitute a more legible English version of P1527, which had already been admitted into evidence.
2. On 25 April 2007, the Trial Chamber granted the Prosecution leave to make the requested substitution.¹ The Chamber noted that the Prosecution was to inform the parties via a written filing once the new legible version was uploaded to eCourt, at which time the Registry shall mark it as admitted into evidence.²
3. In the “Prosecution Notice Regarding Status of English Translation For Exhibit P1527”, filed 27 April 2007, the Prosecution informs the parties that a legible translation of P1527 has been uploaded to eCourt, and requests that the Registry mark P1527 as admitted into evidence.
4. The Trial Chamber, pursuant to Rules 54 and 89, hereby ORDERS that P1527 (and its translation) shall be admitted into evidence.
