

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of the “Defence Request Regarding Exhibit 2D390,” filed on 7 November 2007 by the Šainović Defence (“Motion”), requesting the admission of exhibit 2D390 together with its translation, and hereby issues this order thereon.

1. On 28 September 2007, exhibit 2D390, namely “Federal Ministry of Defence (Civil Defence Sector) Memo Re: Measures for reducing the negative consequences in the event of an attack by the aggressor on objects belonging to the Vinča Institute,” was marked for identification in eCourt, pending translation. In the Motion, the Šainović Defence informs the parties and the Trial Chamber that exhibit 2D390 has been translated into English and uploaded to eCourt. Further, the Defence requests that the exhibit and its translation be admitted into evidence.
2. The Prosecution has indicated that it does not intend to oppose the Motion.
3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS that exhibit 2D390 and its translation shall be admitted into evidence.
