

**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of “Sreten Lukić’s Request Regarding 6D1473,” filed on 12 December 2007 (“Motion”), and hereby issues this order thereon.

1. On 10 December 2007, exhibit 6D1473, namely “37 mtbr Command, Order for special security measures,” dated 15 April 1999, was marked for identification in eCourt, pending translation. In the Motion, the Lukić Defence informs the Trial Chamber that exhibit 6D1473 has been translated into English and uploaded to eCourt. Further, the Defence requests that the exhibit and its translation be admitted into evidence.
2. The Prosecution has indicated that it does not intend to oppose the Motion.
3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS that exhibit 6D1473 and its translation shall be admitted into evidence.
