

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of “Sreten Lukić’s Request Regarding Exhibit 6D1137,” filed on 21 January 2008, “Sreten Lukić’s Request Regarding Exhibit 6D1313,” filed on 21 January 2008, and “Sreten Lukić’s Request Regarding Exhibit 6D1465,” filed on 21 January 2008 (“Motions”), and hereby issues this order thereon.

1. On 25 September 2007, exhibit 6D1137 was marked for identification pending translation. On 26 November 2007, exhibits 6D1313 and 6D1465 were marked for identification pending translation. The Lukić Defence informs the parties and the Trial Chamber that exhibits 6D1137, 6D1313, and 6D1465 have been translated and the translations have been uploaded to eCourt, and requests that the exhibits and their translations be admitted into evidence.
2. The Prosecution has indicated that it does not intend to oppose the Motions.
3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motions and ORDERS that exhibits 6D1137, 6D1313, and 6D1465 along with their translations shall be admitted into evidence.
