THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal"), ex proprio motu, issues this corrigendum to its "Order on Lazarević Defence Notice re Documents Marked for Identification Pending Translation," issued on 1 February 2008 ("Order").

- Due to an inadvertent typographical error in paragraphs 1 and 4(a), the Order erroneously 1. refers to exhibit 5D687 rather than 5D678. The Chamber considers that it is necessary to correct the text of the Order so as to ensure the proper admission status of exhibits 5D678 and 5D687.
- 2. Accordingly, the Trial Chamber, pursuant to Rule 54 of the Rules of Procedure and Evidence of the Tribunal, hereby ORDERS that paragraphs 1 and 4(a) of the Order shall read as follows:
 - In its Motion, the Lazarević Defence notifies the Chamber that outstanding translations of 5D199, 5D208, 5D215, 5D319, 5D666, 5D670, 5D675, 5D678, 5D690, 5D910, 5D911, 5D922, 5D1019, 5D1097, 5D1098, 5D1209, 5D1221, 5D1275, 5D1306, 5D1323, 5D1324, 5D1326, 5D1335, 5D1363, and 5D1370, exhibits which have previously been marked for identification, have now been received and uploaded to eCourt. It thus requests the admission of these documents along with their translations.
 - 4. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS as follows:
 - (a) 5D199, 5D208, 5D215, 5D319, 5D666, 5D670, 5D675, 5D678, 5D910, 5D911, 5D922, 5D1019, 5D1097, 5D1098, 5D1209, 5D1221, 5D1275, 5D1306, 5D1323, 5D1324, 5D1326, 5D1335, and 5D1370 shall be admitted into evidence, along with their translations.
