**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seized of “Sreten Lukić’s Request to Replace the Translation of Exhibit 6D736 in eCourt”, filed on 11 April 2008 (“Motion”), and hereby renders this order thereon.


1. On 4 December 2007, exhibit 6D736, entitled “Command of the 243<sup>rd</sup> mbr /Motorised Brigade/, Regular Combat Report to the PrK /Priština Corps/ Command,” was admitted into evidence pursuant to the Trial Chamber’s “Order re Exhibits 2D12, 5D185, 6D736, 6D1135, and 6D1310.”<sup>1</sup> It subsequently came to the attention of the Chamber that the English translation of exhibit 6D736 contained an error.<sup>2</sup> The Chamber therefore requested the Lukić Defence to obtain a new translation of the document and to notify via a written filing the Chamber and the parties when this version had been uploaded to eCourt.

2. In the Motion, the Lukić Defence informs the parties and the Chamber that it has uploaded to eCourt a new translation of the document, under Doc ID 6D21-0186 and requests leave to replace the previous English translation with the new translation.

3. The Prosecution has indicated that it does not intend to respond to the Motion.

4. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motion and ORDERS that the revised translation of exhibit 6D736 shall replace the previous translation in eCourt, and shall be admitted into evidence.
