**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of the Lukić Defence “Motion with regard to the Testimony of Witness 6D2 with Annex A” (“Motion”), filed 23 April 2008, and hereby renders this order in relation thereto.

1. In the Motion, the Lukić Defence informs the Chamber and the parties that it has reviewed the transcript of the hearings of 15 and 16 April 2008, in accordance with the Chamber’s instruction of 16 April 2008.<sup>1</sup> The Lukić Defence submits that certain portions of the transcript should remain confidential, in order to protect the identity of witness 6D2, whilst other parts, which it specifies in the Annex to the Motion, are general in nature and thus suitable for public release.<sup>2</sup> The Prosecution has indicated that it agrees with the submissions of the Lukić Defence contained in the Motion.

2. Having reviewed the Annex to the Motion and the transcript, the Trial Chamber, pursuant to Rules 54, 69, 75, and 79 of the Rules of the Procedure and Evidence of the Tribunal, hereby **ORDERS** that the following portions of the transcript of the hearings dated 15 and 16 April 2008 shall be made public:<sup>3</sup>
