NOTING the Request of the government of The Netherlands filed by the government of The Netherlands on 2 November 2000,

NOTING the Request by the government of Norway for review under Rule 108 *bis* of Trial Chamber III s Decision on the Motion for judicial assistance to be provided by SFOR and others dated 18 October 2000 filed by the government of Norway on 2 November 2000,

NOTING the Request for review of the Decision on the Motion for judicial assistance to be provided by the Stabilisation Force and others including the United Kingdom filed by the government of the United Kingdom on 2 November 2000,

PURSUANT to Article 14(3) of the Statute of the International Tribunal and Rules 27 and 108 *bis* of the Rules of Procedure and Evidence of the International Tribunal (hereinafter "the Rules"),

CONSIDERING that Judge Claude Jorda has withdrawn from the appeals hearing in accordance with Rule 15(D) of the Rules,
