I, **THEODOR MERON**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991,

**NOTING** the Indictment in *The Prosecutor v Jovica Stanišić and Franko Simatović*;

**NOTING** the “Order Assigning a Case to a Trial Chamber” filed on 30 May 2005, which assigned this case to Trial Chamber III;

**NOTING** the “Prosecution Motion for Joinder” filed confidentially in part on 1 June 2005 (“Joinder Motion”), which seeks to join this case with *The Prosecutor v Šešelj*, IT-03-67 and *The Prosecutor v Martić*, IT-95-11 PT;

**NOTING** the “Order Reassigning a Case and Referring the Joinder Motion” filed in *The Prosecutor v Šešelj*, IT-03-67 and “Order Reassigning a Case to a Trial Chamber and Referring the Joinder Motion” filed in *The Prosecutor v Martić*, IT-95-11 PT on 4 July 2004 (“*Šešelj & Martić* Joinder Motions”), in which the *Šešelj & Martić* Joinder Motions were referred to Trial Chamber III constituted by Judges Robinson, Agius and Liu;


**CONSIDERING** that any Trial Chamber that is seised of the Joinder Motion must also be seised of the cases related to the motion in order to dispose of it;

**NOTING** that the Bureau has been consulted;
