#### **Review Judgement**

On 8 December 2010, the Appeals Chamber rendered the review judgement and reduced Šljivančanin's sentence from 17 to 10 years' imprisonment – *See Press Release number 1377, dated 8 December 2010.*

#### **DEUXIÈME ORDONNANCE PORTANT MODIFICATION DI CALENDRIER (MÉMOIRES EN CLÔTURE, RÉQUISITOIRE ET PLAIDOIRIES FINALES)**

On 6 December 2010, the Chamber modified in part its previous decision and ordered that the closing arguments would be heard from 7 February 2011. The final briefs would still need to be submitted by 4 January 2011.

### HARADINAJ *et al.* case

*Trial Chamber II – Judges Moloto (Presiding), Hall and Delvioe*

#### **DECISION ON RAMUSH HARADINAJ'S MOTION FOR PROVISIONAL RELEASE**

On 8 December 2010, the Chamber granted the motion by Haradinaj and ordered that he be provisionally released from 17 December 2010 until 14 January 2011. However, the execution of this decision will be stayed pending appeal by the Prosecution.

## DECISION ON APPLICATION FOR TEMPORARY PROVISIONAL RELEASE FILED BY THE ACCUSED LAHI BRAHIMAJ

On 8 December 2010, the Chamber denied the motion for provisional release of Lahi Brahimaj.
