GOTOVINA *et al.* case

Trial Chamber I – Judges Orić (Presiding), Ćirić and Gwaunza

Trial Chamber Judgement

On 15 April 2011, the Chamber pronounced its judgement sentencing Ante Gotovina to 24 years in prison, and Mladen Markač to 18 years of imprisonment; Ivan Čermak was acquitted of all charges – *See Press Release number 1402, dated 15 April 2011.*

Rule 98bis hearing

On 11 April 2011, the Prosecution presented its Rule 98bis submissions.

DECISION ON ACCUSED'S FORTY-THIRD TO FORTY-FIFTH DISCLOSURE VIOLATION MOTIONS

On 8 April 2011, the Chamber granted the 43rd (in part), 44th (in part) and 45th disclosure violation motions by the accused and found that the Prosecution had violated Rule 68 of the Rules. Judge Kwon dissented.
