### **PROCEDURAL DEVELOPMENTS**

### I. OVERVIEW OF COURT PROCEEDINGS

#### MLADIĆ case

Trial Chamber I – Judges Orie (Presiding), Flügge and Moloto

#### **Initial appearance**

On 3 June 2011, the accused chose not to enter a plea at this stage. A further appearance is scheduled for 4 July 2011.

### KARADŽIĆ case

Trial Chamber III – Judges Kwon (Presiding), Morrison, Baird and Lattanzi (Reserve Judge)

#### **Continuation of the Prosecution case**

On 31 May 2011, the following witness testified:

• **Radomir Kezunović** (President of the Serbian Municipality of Ilidža during the relevant period)

On 1 and 2 June 2011, the following witness testified:

On 3 June 2011, the trial adjourned following a Defence motion for another suspension of the trial due to alleged disclosure violations by the Prosecution. The Chamber will consider the motion in due course.
