PROCEDURAL DEVELOPMENTS

I. OVERVIEW OF COURT PROCEEDINGS

KARADŽIĆ case

Trial Chamber III – Judges Kwon (Presiding), Morrison, Baird and Lattanzi (Reserve Judge)

Continuation of the Prosecution case

From 5 until 7 December 2011, the trial adjourned due to accused's ill-health.

On 8 December 2011, the following witness testified:

- *Christopher Lawrence (expert witness – forensic pathologist)*

On 8 and 9 December 2011, the following witness testified:

- *András Riedlmayer (expert witness testifying about the destruction of cultural heritage in BiH during the relevant period)*

The trial is adjourned until 10 January 2012 (winter court recess).

STANIŠIĆ & SIMATOVIĆ case

Trial Chamber I – Judges Orić (Presiding), Picard and Gwaunza

Continuation of the Defence case

From 6 until 8 December 2011, the following witnesses testified (*recalled by the Defence*):

- *Manojlo Milovanović (Chief of Main Staff of Republika Srpska Army during the relevant period, now testifying about the Mladić's audio tapes and notebooks)*

The Defence of Simatović is scheduled to commence its case on 13 December 2011.

STANIŠIĆ & ŽUPLJANIN case

Trial Chamber II – Judges Hall (Presiding), Delvoie and Harhoff

Completion of the Defence case

On 8 December 2011, the parties met before Judge Orié for the further appearance of Mladić, who pleaded not guilty to the new charges in the third amended indictment. Subsequently, the parties resumed with a Status Conference.

PEĆANAC case (“Contempt”)

Trial Chamber II – Judges Flügge (Presiding), Mindua and Nyambe

Trial Chamber Judgement

On 9 December 2011, the Chamber rendered its judgement and sentenced Pećanac to three months’ imprisonment – *See Press Release number 1467, dated 9 December 2011.*
