DECISION ON MOTION TO INTERVENE AND STATEMENT OF INTEREST BY THE REPUBLIC OF CROATIA

On 8 February 2012, the Appeals Chamber dismissed the request by Republic of Croatia to intervene in the proceedings and submit a statement of interest.

DECISION ON APPLICATION AND PROPOSED AMICUS CURIAE BRIEF

On 14 February 2012, the Appeals Chamber dismissed the application (by 12 international experts) to file an *amicus curiae* brief relating to international humanitarian law and operational artillery targeting during 'Operation Storm'.

SCHEDULING ORDER ON FINAL TRIAL BRIEFS AND CLOSING ARGUMENTS

On 14 February 2012, the Chamber ordered that the closing arguments would be presented on 21 and 22 August 2012. The parties are to file their final briefs by 31 May 2012.

SCHEDULING ORDER

On 15 February 2012, the Chamber ordered, *inter alia*, that the pre-trial xonference would be held on 17 April 2012, that the opening statement of the Prosecution would take place on 14 May 2012, and that the presentation of evidence would commence on 29 May 2012.
