DECISION ON JELENA RAŠIĆ'S URGENT MOTION FOR PROVISIONAL **RELEASE PURSUANT TO RULE 65(I)**

On 4 April 2012, the Chamber granted the Defence's motion and ordered that Rašić be provisionally released (as soon as practicable) pending the disposition of the appeals.

DECISION ON SIMATOVIĆ REQUEST FOR PROVISIONAL RELEASE
