On 27 March 2013, the Trial Chamber pronounced its judgement sentencing both accused to 22 years' of imprisonment for the crimes committed between April and December 1992 in Bosnia and Herzegovina – *See Press release number 1555, dated 27 March 2013.*

On 26 March 2013, a public redacted version of the President's decision was filed granting the early release of Mladen Naletilić, effective on 18 February 2013.

KRSTIĆ case ("contempt")

Trial Chamber III – Judges Kwon (Presiding), Morrison, Baird and Lattanzi (Reserve Judge)

ORDER IN LIEU OF INDICTMENT

On 27 March 2013, the Trial Chamber ordered the prosecution of Radislav Krstić for contempt of the Tribunal for having refused to testify in the Karadžić case on several occasions and decided to prosecute the matter itself. – *See Press Release number 1556, dated 28 March 2013*
