On 21 June 2013, Judge Meron granted an extension and ordered that the notices of appeal of Prlić, Stojić, Ćorić and Petković be filed within 60 days of the issuance of the English translation of the judgement. The notices of the remaining parties, if any, should be filed within 90 days from the judgement date.
