ORDER ON CLOSE OF PROSECUTION CASE-IN-CHIEF, RULE 98bis PROCEEDINGS, AND PREPARATION AND COMMENCEMENT OF DEFENCE CASE

On 18 July 2013, the Chamber ordered that the Rule 98bis submissions, if any, should be presented 7 days after the close of the Prosecution case. The Defence case, if any, would commence 4 months after the close of the Prosecution case (if there are no Rule 98bis proceedings) or 4 months after the Rule 98bis judgement (unless it results in full acquittal).
