Appeal judgement

On 23 January 2014, the Appeals Chamber rendered its judgement reducing the sentence of Šainović from 22 to 18 years' imprisonment, the sentence of Lukić from 22 to 20 years'

and of Lazarević from 15 to 14 years' whereas the Pavković's sentence of 22 years was affirmed – *See Press Release number 1594, dated 23 January 2014.*

DECISION CONCERNING DEFENCE MOTION TO EXCEED WORD COUNT AND DEFENCE MOTION PURSUANT TO RULE I5 (B) SEEKING DISQUALIFICATION OF PRESIDING JUDGE ALPHONS ORIE

On 22 January 2014, President Meron denied Mladic's Defence motion for disqualification of Judge Orié finding it "unmeritorious" as the Defence had not demonstrated "that a reasonable observer, properly informed, would reasonably apprehend bias" by Judge Orié.

DECISION CONCERNING DEFENCE MOTION TO EXCEED WORD COUNT AND DEFENCE MOTION PURSUANT TO RULE I5 (B) SEEKING DISQUALIFICATION OF JUDGE CHRISTOPH FLÜGGE

On 22 January 2014, President Meron denied Mladic's Defence motion for disqualification of Judge Flügge finding it "unmeritorious" as the Defence had not demonstrated "that a reasonable observer, properly informed, would reasonably apprehend bias" by Judge Flügge.
