On 26 February 2014, the Chamber ordered that Rule 98*bis* submissions in this case would be heard from 17 to 19 March 2014 and that Mladić Defence case would commence on 13 May 2014 preceded by the Pre-Defence Conference a day before.

# DECISION ON MOTION REQUESTING RECUSAL OF JUDGE LIU FROM ADJUDICATION OF MOTION TO VACATE TRIAL JUDGEMENT

On 24 February 2014, the panel of three judges, appointed by Judge Agius, the Acting ICTY President, denied the Defence's motion for recusal of Judge Liu from considering the Zupljanin's motion to vacate the trial judgement. The Panel found that the Defence had not

demonstrated a "reasonable apprehension of bias on the part of Judge Liu from the standpoint of a reasonable observer." Furthermore, the Chamber was not "convinced by the submissions of the Defence that Judge Liu, having previously dissented on the issue of disqualification of Judge Harhoff, would be unable to impartially decide on the Motion to Vacate the Trial judgement."

#### ORDER ASSIGNING JUDGES TO A CASE BEFORE THE APPEALS CHAMBER

On 24 February 2014, the Mechanism President Meron assigned an Appeals Chamber of the MICT to decide on Milan Lukić's application for review of the trial judgement, filed on 6 February. The Appeals Chamber consists of Judges Meron, Antonetti, Sekule, Agius and Liu.
