DECISION ON TRIAL SITTING SCHEDULE

On 28 March 2014, having received the medical reports and the subsequent submissions of the parties, the Chamber ordered a five-day sitting schedule for the Defence case, if any. The Registry was instructed to arrange for the medical examination of the accused on an ongoing basis at least every four months. The trial will sit daily from 09:30 to 14:15, including three breaks of 20 minutes.

STANIŠIĆ&ŽUPLJANIN case

Appeals Chamber – Judges Agius (Presiding), Sekule, Robinson, Daqun and Ramaroson

DECISION ON MIĆO STANIŠIĆ'S MOTION REQUESTING A DECLARATION OF MISTRIAL AND STOJAN ŽUPLJANIN'S MOTION TO VACATE TRIAL JUDGEMENT

On 2 April 2014, the Appeals Chamber dismissed the two Defence's motions, namely the Župljanin's to vacate the trial judgement and the Stanišić's to declare a mistrial due to alleged bias of Judge Harhoff. The AC was not persuaded that the findings made by the

Special Panel in the Šešelj case regarding Judge Harhoff's partiality constituted extraordinary circumstances that require an interlocutory decision on the matter in this case. Since Judge Harhoff's alleged partiality in this particular case had not been determined, there was no basis for the claim of "ongoing prejudice", as submitted by the Defence, during the appeal proceedings, the Chamber concluded. Subsequently, no justification was found to stay or terminate the appellate proceedings in this case.
